Opening address: Greg Sutherland acknowledgement of country and thanks to ASSI.PJ for hosting the meeting as well as apologies for being late.

#### **Greg Sutherland opening comments:**

- The work done by people to get us to where we are has been very beneficial
- Considerable tasks still to get the work done
- Simple task from Greg's perspective in coming up with constitution there are instructions in what that should look like
- ASSI.PJ made valuable contribution and we are able to launch off that
- The processes of the Wantok's were palatable or not palatable that's democracy at work there's days I get bowled over.
- These tasks aren't about being popular
- Attempts to create unity aren't always going to happen due to demographics eg: cultural, political and heritage
- NASSIGWG have been tasks to come up with a constitution
- Greg's not a candidate for any future committees / elections and wont go beyond the election process, one reason is health
- Process for ASSI constitutional development is simple
- Being NASSIGWG Chair allows for change management / criticism due to not running for election. The purpose is to get the project at hand to an ends.
- How far have we come 20 years after recognition. What has changed for ASSI in regards to housing, education, social justice etc 'Not much of anything"
- Greg's personal perspective is all efforts to get up local, state, national bodies haven't worked due to the personalities instead of looking at the task at hand
- Emelda is very persuasive in regards to PJ Sydney perspective and spoke of other NASSIGWG members Dallas Fewquandie, Mable Quackawoot, Dennis Bobongie
- Two other members on NASSIGWG now that Greg has checked with Gilbert and Tobin –
   Fiona Bobongie (nee Mann) (Townsville) and Fiona Mount (Tweed)
- Our role is to come up with a constitution for a not for profit company limited by guarentee then that committee is to look after the national interest of everybody
- Greg speaks on ASSI history
- With due respect, Lola Forester asked to refrain from ASSI history talk and progress to business of the day since the ASSI.PJ members have a great appreciation of ASSI history given the work done to date.
- Lola Forrester suggest we move forward with the purpose of the meeting due to time constraint as everyone has been waiting for more than 1 and half hours and some people have already left.

Lola Forester, can we discuss your thoughts and ASSI.PJ will come back to you on our recommendations for constitutional developments. AGREED by all.

### **Greg Sutherland's personal thoughts:**

People applying for this position must demonstrate a national focus. This is a National representative body.

- Issue is to get 8-10 people in place for 12 months as NASSIRB
- The concept is supported by G&T to expedite the formation
- Rotary has funded 2,500 for an ASSI think tank of 20/25 people to travel to Mackay in the near future
- Locations we will invite from Cairns, Innisvale, Townsville, Berdekin, Rockhampton, Gladstone Sunshine Coast, Tweed, Lismore and Sydney x 2, Gilbert & Tobin x 2 - a 1 day in and out workshop on constitution.
- From think tank 20/25 will be asked to recommend from your associations suggest 3 or 4 people to get us our first 100/120 members for the organisation
- The 100/120 are then responsible to elect the first 8-10 board members who are nominated from an association
- The 100/120 selected go off and vote on the 8/10 nominated
- 8/10 elected vote on a chair
- If the 8/10 want to replace the chair the chair stays the director but they can replace the chair through an internal vote
- Going through the AEC wont be personalising the voting process in setting poll in eg: Gladstone for 5 people it will be postal
- Sub committees are the discretion of the 8/10 board that will decide on task or specialist commitment of those groups eg: international relations, Finding family, youth
- People seem to think that ASSI.PJ were sacked and I have advised on my travels when asked that they have handed over they were not sacked.
- Wantok has bought together community groups in Mackay particularly that have not spoken in years.
- Gilbert and Tobin will have a draft constitution on the once I have completed the consultations and suggested holding off on the next NASSIGWG newsletter until the draft constitution is ready.
- Final consultation are in the Berdiken

**Summary:** Greg Sutherland wrapped up in stressing the importance of having a constitution in place. Have a committee elected, give them 12months to run, as there's enough well educated people in the community. A think tank is the way to go with selections from ASSI organisations and communities in youth, elders etc to come up with those first 100/120 members.

Emelda then in closing, thanked everyone for attending.

#### **ASSI.PJ CONSTITUTIONAL DEBRIEF MEETING**

29<sup>th</sup> June 2014 - 1pm to 6:23pm closed

**Summary:** ASSI.PJ Board revisited the video recordings from constitutional meeting with Greg Sutherland and have agreed on the below dot points to be put forward to Gilbert & Tobin, NASSIGWG and the ASSI Community for wider consideration. Please bare in mind that theses points are just suggestions and collated feedback from those who attended.

### **ASSI.PJ board and members recommendation:**

Shireen Malamoo suggested that we think carefully while nominating and voting, as it is very important that we have the right people representing us to be able to write submissions and have the savvy to work hard in a voluntary capacity and lobby the ministers on the needs for Australian South Sea Islanders.

Selection process if agreed for the first 100/120 needs to be a transparent process that the broader ASSI community agree with. How do we identify and verify their heritage? They need to demonstrate commitment track record in community development and in particular ASSI Affairs.

The Wantok delivery since 2012 has collated 1,000 registered community members with our largest numbers coming from Bundaberg conference participants that committed to a national voice and development of the terms of reference paper that has been widely distributed.

The 1000 members are owed the opportunity to participate in all phases of development as their democratic right. There are expectations of this current group to participate in the refined developments and the delivery for election as agreed by participants at Wantok Mackay.

## Points for consideration that were raised at meeting:

# **Delegates election:**

- No confidence in the suggested voting process in that it is culturally inappropriate and doesn't demonstrate transparency.
- Who are we to say who is worthy more than others in denying a democratic voting process.
- NASSIGWG was allocated the task to do the ground work in developing a national constitution and taking it back to community then elections.
- Young people should be strong voiced and politically minded to continue the recognition and work to be done for ASSIs. What young people have been encouraged and consulted to date.
- Nominees need the credentials and be committed to do the voluntary work regardless of other commitments. (availability to commit time/hours per week).
- We need strategic, diplomatic, open minded, flexible people who are able to get good results.
- Letters of support x 3 for all board applicants
- Media savvy and cyber connected
- Police checks pending criteria

- Establish a 'risk management team'
- · Establish 'funding strategy team'

# Constitution points for consideration of inclusion/discussion:

- The story of South Sea Islander History is an untold story, which is why it needs to be told nationally and abroad.
- Work smarter not harder principle to tackle the Government, and one day take it further to the UN.
- Constitutional statement (included) that recognizes and commits to our Pacific Island nations for future development of bilateral relations eg: finding family, economical and social needs etc.
- Blanket national insurance for NASSIRB to cover unregistered ASSI community groups / organisations.
- Friends of the NASSIRB are support groups who can be ex patriots that raise funds for the
  organization eg: ex patriots (people of influence) of the South Pacific Islands who have a
  sound knowledge and relationship with the Islands and Australian History. Individual
  humanitarians, Academic, Churches, Philanthropist, Kastom and Cultural objectives, (ASSI,
  SSI or Non ASSI) (there needs to be a commitment in the constitution to maintain/recognise
  such relations)
- Pacific Nations / Community need to be considered in terms of their membership as associate members.
- Kastom and Cultural practices should be respected due to knowledge and cultural connections that exist within our communities. (eg: Our forefathers name children with traditional names as a means of identity and cultural maintenance.)

## Following Greg Sutherland meeting the below email sums up the next stage of development:

Thank you.

Following discussions I had with Darren Filter of Gilbert & Tobin, I am keen to finish the consultations before we meet again.

This will allow us to go forward with confidence that we have discussed far and wide.

It is impossible to gather in everyone. I suggest we meet next Tuesday thanks.

Darren has also agreed that we now appoint the two other ladies to our /Working Group and I will officially contact them today.

We have the list of possible attendees to the meeting in Mackay to discuss a Draft Constitution prior to it going our to the National Community.

On option, which I prefer from Gilbert & Tobin, is that we then ask that 20-25 people to select 100-120 ASSI people who are the first members of the National "Council/Recognition Group/Association".

Having been tasked to do a job, we will have done it correctly. After the first year of office, the new National Body can then call elections etc and go about increasing memberships and setting up sub committees for Elders, Youth, Finance, International Representation and the like.

When calling Nominations we need to have a simple job description for candidates and they need to advise of their skills and abilities to be a National rep.

But is impossible to call on State Committees to nominate people as there are none in existence. People will need, I would suggest, to nominate, have a nominator from the 125 people and attach their bio or resume.

In the first term we need strategic think people as they must put a 3 year Strategic Plan into place. They also need to gather funding and credibility with all levels of government and inform the wider community of their role and existence.

I am off to anther meeting now but will catch up withyou all later.

### Response from Gilbert & Tobin in ASSI.PJ requesting feedback from meeting with Greg Sutherland:

June 25th Peter Pereira, Darren Fittler

Dear Emelda,

Thanks for your email. It was good to meet with Greg last week and to hear of the progress that has been made through the consultation process. We hope the weekend's meetings in Sydney were productive as well.

Our discussion with Greg focussed on how we can get the national association off the ground as soon as possible. Most of what we discussed was not new; a lot of it was similar to what we have been discussing for some time now.

While we didn't agree that anyone in particular should be appointed to the working group in place of those no longer part of it, we did agree that if the working group followed due process there was no reason why the group couldn't bolster its diminished numbers to better get the job done.

So far as getting the job done goes, in terms of electing the first board of directors, we discussed the pros and cons of going to a full constituent based election (where all the many hundreds, if not thousands, of members vote) to elect the first board, versus a smaller group of people appointing the first board of directors who might only hold office for 1-2 years, but will allow the association to get off the ground before a full-scale election is held for a board of directors to hold office for a longer period of time.

It has been suggested that a meeting in Mackay to elect the first, temporary, board of directors would take place and although we made no suggestion as to how many people should attend that meeting, we note a couple of issues that would need to be resolved before any meeting took place. The first is to work out how to determine the candidates for the director positions, and the second is to determine who would vote in an election for those directors.

The process would have to be open and transparent but in the interests of expediency, not all South Sea Islanders might be involved. If this model ensures that the national association gets off the ground and onto its feet, then that could be preferable to trying to run a full-scale election from the

get go, which could run into all sorts of administrative and logistical hurdles. As the saying goes, "don't let the best be the enemy of the good".

Importantly, if the expeditious approach is adopted, some of the South Sea Islander community will need to be convinced that it is fair and right. The message is that this approach is temporary but best allows us to get on with the job of incorporating an association for all Australian South Sea Islander people.
